TODAY'S PROGRAM... *Scio Township Update*

Doug Ziesemer introduced today's speakers—Bryce Kelley, Scio Township Manager, and Jack Knowles, Scio Township Supervisor. **Doug** commented that our club leadership's positive impression of Scio Township government was an important part of the decision to purchase our current location. The goodwill between our club and the township officials was clear.

Bryce said he is the play-by-play man for the township, making sure things get done on a daily basis. It's Jack Knowles responsibility to take the longer view of township issues. According to Bryce, township residents love their open spaces, support good roads, and want growth managed carefully. Scio Township is enjoying steady growth, and township leaders are working to guide that growth to make the community stronger. Bryce said Kiwanis fills a need in the community that the township is unable to fill, and our move was a positive and welcome development.

Jack Knowles admitted he was in the same high school class with President-Elect **Dan Dever**. Nonetheless, Jack went on to a successful career in community governance. Jack reviewed current and planned township activities

and then took questions from the membership. The top item now is the implementation of a preferred community trash hauler. Contract negotiations are in progress with the selected vendor, GFL Environmental. The new system should be in place around July of this year. A pedestrian pathway has been started along Zeeb Road that will eventually connect with the Border-to-Border trail currently being developed along the Huron River to the north. A park project is being planned behind the township hall. The township recently completed a \$1.8 million expansion of the township hall to better house utility department operations. A \$1.3 million project to improve the fire hall is also being planned. About 1,800 acres have been preserved so far through the township's land preservation millage.

Jack was asked about the future of water rates and the high cost of water from Ann Arbor—expect continued cost increases as the township builds and maintains water infrastructure and as authorities deal with issues like PFAs contamination. A question was asked about building height and setback limits—the township relies on Washtenaw County to handle building permits. Township zoning limits building heights to 35 feet, primarily based on the height the fire department can reach. A question regarding the source of the name "Scio" led to a brief history lesson from **Jim Dries** who related that it's a reference to a famous massacre on the island of Chios during the Greek Revolution of 1821-32.

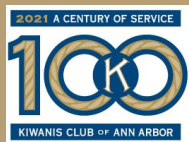

A MOTION Approved by the KIWANIS CLUB OF ANN ARBOR BOARD and the KIWANIS CLUB OF ANN ARBOR FOUNDATION BOARD.

March 19, 2019

Background Information: *In recent years our Club and Foundation Boards and individual members explored and discussed a range of possible steps to consider to more clearly separate the legal responsibilities of our Kiwanis Club of Ann Arbor and our Kiwanis Club of Ann Arbor Foundation, Inc. while continuing the long and honored shared history of these entities. At a recent Board training session this was once again discussed. As part of February 19, 2019, Boards' meeting, the Boards supported a motion to explore some changes to the Boards' makeup within the parameters of current By-Laws for our Club and separately for our Foundation. The 2019 Nominating Committee discussed the impact of the Boards' action and requests that the two Boards consider the following detailed motion to provide further clarification and direction not only to the two Boards, but also the Nominating Committee, as well as our general membership for the upcoming annual Club and Foundation Boards' election scheduled for May 2019.*

It is believed that these changes are within the parameters of our current By-Laws for the Kiwanis Club of Ann Arbor and the Kiwanis Club of Ann Arbor Foundation, Inc. There may, however, need to be some updating of our two Manuals for Administrative Procedures.

The following item is presented for consideration for Action by the Boards, 1st reading.

MOTION: The Kiwanis Club of Ann Arbor Board and the Kiwanis Club of Ann Arbor Foundation Board approve the following changes to the current responsibilities and duties of our Boards' Club and Foundation Officers positions of Treasurer and Secretary effective October 1, 2019 and going forward.

1. This motion changes our Boards' Officers positions from having one Treasurer and one Secretary to create two Treasurers and two Secretaries as separate Board Officer positions as follows:
 - a. **A Board Officer of Treasurer for the Foundation** who is responsible for our Foundation financial activities. This Officer would be a voting member of the Board but, can only make or support motions and vote on Foundation items of the Board agenda.
 - b. **A Board Officer of Secretary for the Foundation** who is responsible for our Foundation secretary activities. This Officer would be a voting member of the Board but, can only make or support motions and vote on Foundation items of the Board agenda.
 - c. **A Board Officer of Treasurer for the Club** who is responsible for our Club financial activities. This Officer would be a voting member of the Board but, can only make or support motions and vote on Club items of the Board agenda.
 - d. **A Board Officer of Secretary for the Club** who is responsible for our Club secretary activities. This Officer would be a voting member of the Board but, can only make or support motions and vote on Club items of the Board agenda.
2. This motion supports that these changes be part of the current election process for our Club and Foundation Boards' Officers and Directors to be held as part of the annual meeting in May 2019.

A MOTION Approved by the KIWANIS CLUB OF ANN ARBOR BOARD and the KIWANIS CLUB OF ANN ARBOR FOUNDATION BOARD.

March 19, 2019

3. Secretary Election/selection/appointment: This motion supports continuing the process that the positions of Secretaries are not voted on, selected, or approved by the general membership but by the two Boards per our By-Laws for the Club and separately for the Foundation.
4. Roles and responsibilities of other members of the two Boards: This motion does not change the current roles, responsibilities, and numbers of the Boards' positions of the Board President, the Board President-Elect, the Board Past-President and the six (6) Board Directors. These positions shall continue to represent and have a full range of duties and responsibilities to both the Club and Foundation.
5. Size and quorum of the Board: This motion does not change the total number of Board members (Officers and Directors) voting on an individual and separate Foundation or Club Board item and that total would remain at the current total of eleven (11) as the voting duties of the proposed redefined positions of Treasurer and Secretary are limited in that these redefined Officer positions can only vote on items that are within their identified duty to the Club or to the Foundation.
6. Boards' Meeting Agendas: This motion supports that any possible changes to how the two Boards' meeting agendas are organized and presented after October 1, 2019 and going forward remains under the authority of that future President with the approval of those future Boards.
7. Support review of current duties: This motion supports the President in establishing a special short-term committee to review and propose changes to the current list of duties and responsibilities for the two Boards Treasurers' and Boards Secretaries' positions to support these changes.
8. Request President-Elect review the annual non-voting support positions to the two Boards: This motion requests that the current President-Elect meet with the current non-voting support positions of the Assistant Secretary, the Assistant Treasurer for the Club and the Assistant Treasurer for the Foundation Thrift Sale to discuss and determine their continued interest and possible changes to those positions.
9. This motion does not change the basic roles and responsibilities of the staff position of Administrative Assistant.

Kiwanis Scholarship Program 2019

How the Program Works:

Kiwanis will support two categories of "full ride" scholarships at Washtenaw Community College in 2019 - 20. Category One will consist of eight scholarships for first year students who are Ann Arbor residents and 2019 graduates of the Ann Arbor Public Schools with financial needs. Category Two will consist of 10 students, also AAPS graduates, who have successfully completed their first year at WCC, but who would probably be unable to continue their studies without additional financial support. Each scholarship in both categories will be for \$3500, which will cover tuition, books, and fees for the entire year. Students will need to successfully complete their first semester studies in order to be eligible for second semester funding. Kiwanis will also contribute \$2000 to an emergency fund which students with unexpected hardship expenses can draw upon when necessary.

The Kiwanis Club of Ann Arbor Board of Directors and the Children and Youth Services Committee have together budgeted \$18,000 for academic scholarships this year. In addition, the Cross Foundation has again generously agreed to "match" the individual donations of Club members. The following chart describes our financing plan.

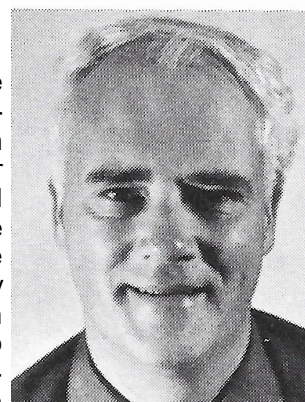
